How to access your W-2 electronically

To download your 2023 W-2 in WorkSight, please follow the steps below:

- Go to https://worksight2.gnapartners.com/login.
- Enter your credentials to log in.
- Once logged in, select "Taxes" from the left tab menu.
- Then click "W-2."
- Click the box that says "Select a Year" to view the available W-2 forms on file.
- Once you select the year, click the blue download button next to the box.
- This will save a PDF file of your W-2 form to your device.

How to determine whether you registered for an electronic W-2

If you're unsure whether you registered to receive your W-2 electronically, please follow the steps in section above. When you get to the step "Select a year," if you don't see 2023 in the drop-down menu, then you are not registered for electronic W-2 delivery.

- Please don't panic! Employees who didn't register to receive their W-2 electronically will receive it via mail by Jan. 31, 2024, to the address we have on file as of Dec. 31, 2023.
- All 2023 W-2s will be available online by Jan. 31, 2024.

Although it is too late to register to receive your 2023 electronic W-2 early this year, now is a good time to register to receive your W-2 electronically for 2024 and future years. <u>Please click on this link to download our guide</u>, which provides detailed instructions.

How to reset your WorkSight password

If you're having trouble logging in to WorkSight, you can easily reset your password by following these steps:

- Go to https://worksight2.gnapartners.com/.
- Type your email address in the "Email" box.
- Click "Next."
- Then click "Forgot Password."
 - WorkSight password reset instructions will be sent to the email address associated with your WorkSight account.
 - Please check all email addresses you may have on file, as well as your spam and junk folders.
