<b>What is the overall <a href="#">deductible</a>?</b>	For <a href="#">in-network providers</a> : \$5,000/individual - employee only or \$10,000/family maximum (no more than \$5,000 per individual - within a family) For <a href="#">out-of-network providers</a> : \$10,000/individual - employee only or \$20,000/family maximum (no more than \$10,000 per individual - within a family) Combined medical/behavioral and pharmacy <a href="#">deductible</a>	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
<b>Are there services covered before you meet your <a href="#">deductible</a>?</b>	Yes. In-network <a href="#">preventive care</a> & immunizations.	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply. <b>What is the <a href="#">out-of-pocket limit</a> for this <a href="#">plan</a>?</b>	For <a href="#">in-network providers</a> : \$6,750/individual - employee only or \$13,000/family maximum (no more than \$6,750 per individual - within a family) For <a href="#">out-of-network providers</a> : \$13,500/individual - employee only or \$26,000/family maximum (no more than \$13,500 per individual - within a family) Combined medical/behavioral and pharmacy <a href="#">out-of-pocket limit</a>	The <a href="#">out-of-pocket limit</a> is the most you could pay in a year for covered services.
